**Arlington Partnership for Affordable Housing (APAH)** one step closer to its goal of building 122 new, affordable homes in the changing Columbia Pike corridor. "**APAH** is honored to partner with Arlington County in pioneering the use of 'Public Land for Public Purpose,'" said **APAH** President/CEO **Nina Janopaul.** "The discounted, 75-year ground lease is a great tool for creating affordable housing for lower-income families, offsetting the escalating land prices in our community." If financing is secured, construction will begin in spring 2012.

### "Hot Markets, Cool Places"

The theme of this year's report on the Arlington economy is "Hot Markets, Cool Places." No market is hotter than Rosslyn, where we have seen four ground-breakings for new construction within the past few weeks. The biggest event was the start of 1812 N. Moore Street this past October, soon to be Arlington's tallest building and one of our largest at 570,000 square feet of office space.

December saw the beginning of construction on Gaslight Square, a 117 unit luxury condominium project by ABDO and the only new condo project in years. More residential development began construction with the groundbreaking of two residential towers by JBG – Sedona and Slate, containing 479 rental units and 12,600 square feet of retail space. Finally, demolition has taken place and construction has begun on Skanska's 1779 Wilson project, a 109,000 square foot office project with 28,000 square feet of retail space. And that is just for "starters."



A number of new development projects are working their way through the entitlements process, including JBG's Gateway project and the redevelopment of Rosslyn Plaza project by the Vornado/Gould interests. The latter proposes a replacement for the Spectrum, which would add to the Artisphere which opened in October as Arlington's largest cultural and entertainment venue.

After a couple of years that have been a little light in terms of new development, Rosslyn is jumping. #### Bottom line from this roundtable?


Increase probability of success. It establishes trust, which is the yellow brick road to a prospect's acceptance.
