### Signs of the Future

### New sign ordinance offers flexibility, opportunity for businesses

Businesses looking to showcase their presence in Arlington with signage now have clear standards in doing so, as well as additional flexibility in the types of signs and placement. After an eighteen-month planning process, the Arlington County Board adopted revisions to the Zoning Ordinance's sign regulations earlier this month that will make Arlington's signage rules easier to understand and allow administrative approvals for most requests, while at the same time providing businesses the opportunity to effectively highlight their presence in Arlington.



"The new ordinance is a win-win for businesses and Arlington residents," said **Marty Almquist**, chair of the Arlington Economic Development Commission. "Not only does it give our businesses the crucial flexibility to effectively showcase their location here in Arlington, but it provides very specific guidelines and standards on exactly what kinds of signs are permitted in each location."

The revisions will simplify the process for small businesses to get signs approved by providing specific instruction and clear standards on the types of signage allowed based on zoning and increased flexibility in signage to encourage creativity and options in signage technology and placement. The revisions also include new standards for architectural lighting and illumination, temporary signage, and for signs placed above a height of 40 feet, as well as new limitations on roofline signs that face the National Mall and other national lands and signs within 100 feet of high-rise residences.

The proposal to amend the sign regulations, part of Arlington's Zoning Ordinance, started when the County Board accepted a two-year work plan in December 2010. It's all part of the County Board Chairman's Small Business Initiative, led by then-Board Chairman Chris Zimmerman, to address concerns from the business community on the regulation of signs and the approval process for getting a sign.

While most of the original intent to streamline and liberalize the sign ordinance provisions was met, the elements relating to rooftop signs (those signs above 40') produced great controversy. While the County staff originally proposed removing the discretionary provisions of approval and making rooftop signs an administrative action, some community members and the Planning Commission wanted them prohibited in any location. The County Board ultimately adopted a rather complex approach which makes some approvals administrative, some discretionary and dependent on Board action, and prohibits some signs adjacent to national monuments and the Monumental Core altogether. Businesses and developers seeking rooftop signage should contact the Arlington County Zoning Administrator for an interpretation.

The Board also adopted a process for both grandfathering existing signs and bringing non-conforming signs into compliance. Again, the Zoning Administrator can determine how the new ordinance applies to any existing signage.

### If a Shoebox is Your Bookkeeping System, What Happens When Business Picks Up?

When starting a business you wear all the hats. Since you're in business to make a profit, finance is one of your responsibilities. Keeping track of income and outflow is the only way to keep score, and that involves a bookkeeping or accounting system. Set up the system as one of the essential first steps to starting the business.

Many thanks to John Bowen, Bookkeeping & Money Management, as he unraveled the complexities of bookkeeping for a small business. John uses a step by step method of selecting the appropriate bookkeeping/accounting system.

Questions to ask in setting up a bookkeeping system:

- Step 1: Determine the type of legal entity to establish: Corporation, Partnership, Sole Proprietor, or LLC?
- Step 2: Will you have employees, use Independent Contractors, or hire Subcontrac-
- Step 3: Will you collect sales tax? Need to track inventory?
- Step 4: Do clients/customers pay immediately or in stages?

Common problems small businesses experience are:

- · Keeping up to date on income includes tracking when invoices are sent, paid and deposited
- Prompt reconciliation of bank and credit card statements is essential. It is easier to catch an error in one month than searching through three or more months for the problem

### Popular software options:

- QuickBooks Pro (Windows) and for Mac \$180
  - Broad array of reports (including complete balance sheet)
  - Handles employees and independent contractors (prints W-2s and 1099s)
  - Handles sales tax
  - Tracks inventory
- Quicken Deluxe (Windows) \$60 and Quicken Essentials for Mac \$50
  - Can combine personal and business transactions, and do reports on each
  - Better for downloading
  - Better for tracking investments
- Can include personal and business bank and credit card accounts
- Quicken Home and Business (Windows) \$90
- Does invoices and tracks receivables
- Tracks sales tax
- Cloud: QuickBooks online \$40 per month
- Expensive, but is efficient if more than one location is using the system

### The Bottom Line from this roundtable?

The time to set up the booking/accounting system is at the start of the business, and you will want to set it up for the business it is going to be.


