

CHAIR'S MESSAGE

The last full measure of devotion

On May 28, 2012 we will once again celebrate Memorial Day. To many the day represents a glorious three-day weekend. Time off from school or work, it also means the opening of local community pools, the inaugural 'beach weekend', parades, concerts, and the first weekend of the year wherein the fashionconscious among us would say that it is appropriate to wear white clothing. Grills awaken from their winter slumber and summer foods mark their arrival at backyard patios and on picnic tables throughout America. And of course the weekend also offers the promise of the coming summer! Yet as this holiday approaches allow me to ask a question: When was the last time you thought about the original purpose of Memorial Day?

Memorial Day is a United States federal holiday observed annually on the last Monday of May. Formerly known as Decoration Day, it originated after the Civil War to commemorate the fallen soldiers. By the 20th century Memorial Day had been extended to honor all Americans who have died in all wars.

Following is a snapshot of the terrible price that has been paid in just some of our nation's wars: In the war to end all wars (WW I) over 116,000 died. In WW II over 405,000 died. The Korean War: 36,574. Vietnam: 58,220. The war on Terror: 6,386 (and regrettably, still counting).

In many of these wars the rescue from tyranny began with the arrival of our troops. In many of these wars, men and women died before ever realizing the great joys of life. In virtually all of our nation's wars, all gave some and some gave all.

The price paid by the brave men and women who died while serving our country has secured a number of important freedoms that we enjoy (and often take for granted) today. Besides our democratic form of government those freedoms include being able to live in a society where people have the freedom to start their own business or work for the employer of their choice, to engage in trade and commerce, and to invest in opportunities that encourage growth and investment.

So please join me in thanking all of the men and women who have served or are serving in our nation's military. And when they have retired or fulfilled their tour of duty and apply for a job please put their application at the top of your list. Their skills, training, and character represent a profile that is well-worth consideration for employment at your organization. It might just be one of the best business decisions that you will ever make.



ACF Announces the 100 Homes Campaign Fund

The Board of Trustees of the Arlington Community Foundation (ACF) announced at the beginning of April the creation of a new fund, The 100 Homes Campaign Fund, dedicated to housing Arlington's most vulnerable homeless citizens. The creation of the Fund was led by the efforts of John G. Shooshan of Arlington-based The Shooshan Company, a local developer strongly committed to alleviating homelessness in our community. The \$500,000 gift to establish the Fund represents the private sector's match from Arlington County's pledge to also dedicate \$500,000 toward this same goal. The 100 Homes Campaign is Arlington's part of the state-wide 1,000 Homes for 1,000 Virginians Campaign as an initiative of the national 100,000 Homes Campaign to get the most vulnerable and long-term homeless individuals into permanent, supportive housing.

2012 Valor Honorees:

The Arlington County Office of Emergency Management

Life-Saving Award: Emergency Communications Team On January 10, 2012 the Emergency Communications Center (ECC) received a call reporting a suicide threat about a young man who told his ex-girfriend's sister that he was going to jump off the Key Bridge, then disappeared from the premises. At the same time, personnel in the ECC were working on another high priority call of a missing adult female who was bipolar, had stopped taking her medication, and had fled from her sister's car. The dispatchers diligently worked to communicate with officers, showing excellent teamwork and investigative skills by gathering information quickly and accurately to locate the individuals. Due to their quick actions, both missing persons were found unharmed.

The Arlington County Fire Department

Meritorious Service Award: Battalion Chief Christopher Devers Chief Devers has served as the Fire Department's Special Operations Chief since his promotion to the rank of Battalion Chief in 2010. He is always a professional representitive of the Fire Department while displaying exceptional judgement, performance, teamwork and dedication. One of his recent accomplishments was his work to incorporate training and performance competencies for the hazardous material and technical rescue teams.

Life-Saving Award: Firefighter I Joaquin Ibarra & Firefighter II Corey Sherrill Engine 109 was on the way to an assignment in Faifax County on September 8, 2011 to assist in rescue efforts resulting from severe flooding in the area when they encountered twelve people stranded on top of their cars. They devised an action plan including personal flotation devices, tag lines and rope anchors to remove the victims from the fast and rising floodwaters. Because of their decisive and competent action, all twelve victims were brought to safety.

Life-Saving Award: Firefighter II Alexander Dimoff, Lieutenant Jacob Johnson, Battalion Chief Stuart Insley, Firefighter II Mark Jaquays & Firefighter II Chad Stamps

In the early morning hours on June 1, 2011, Arlington County Fire Department units responded to a reported house on fire. When they arrived on the scene, a man came up to Engine 102 officer and said his wife was still trapped inside. Through their swift and competent actions, the firefighters of Engine 102 worked together to find and rescue the trapped 53 year old woman, who surely would have otherwise perished.

The Arlington County Sheriff's Office

Meritorious Service Award: LaShawn Fisher

LaShawn Fisher has been employed with the Arlington County Sheriff's Office since September 2001 in the Inmate Services section. Throughout her time there, she has been promoted a number of times and is currently the Inmate Services Supervisor. Known for her dependability and commitment to the agency, Fisher is often called upton to work on outside committees and conduct interviews for hiring new employees.



Valor Award: Lieutenant Jimmie Barrett, Jr. On his way home one day, Lieutenant Jimmie Barrett, Jr. was riding the metro when the train operator announced a person either fell or jumped onto the tracks and was either struck or run over. Off duty but still in uniform, Lt. Barrett immediately took action. After learning the victim was still alive and trapped under the train, he climbed onto the tracks - knowing the third rail was still powered - to make contact with the victim. He assessed that the victim's injuries and position were life threatening, and could tell the victim had significant mental health issues. Lt. Barrett stayed with the victim, trying to keep him engaged to ensure he would not further harm himself, until he was extracted and transported to the hospital. Unfortunately, the victim succumbed to his injuries. The police captain who responded to the incident reported that the victim's chances for survival were significantely increased by Lt. Barrett's efforts.

The Arlington County Police Department

Meritorious Service Award: Ann Mountjoy

Ann Mountjoy was hired with the Arlington County Police Department in 1975. For 37 years she has always performed above and beyond what was expected of her. Her exceptional level of service has

been noticed throughout the years by both her co-workers and citizens she has assisted. In October 2012, Mountjoy will retire. She will be greatly missed, but her legacy will live on.

Life-Saving Award: Officer Sara Balch & Officer Sean Gilligan

On February 24, 2012 Officer Balch responded to a report of a man who was standing on a telephone pole with a rope tied around his neck. Just as she arrived on scene, the victim stepped off the pole and fell, left hanging by a rope tied around his neck. While Officer Balch attempted to reach the victim by jumping on nearby trash cans, Officer Gilligan arrived on scene. He climbed the telephone pole's ladder and cut the rope with his knife as several citizens supported the victim. Officer Balch, assisted by others, caught the victim as he fell. Thanks to the quick actions of these officers, the victim is expected to live.

Life-Saving Award: Officer Jason Cox, Corporal Jim Mastoras & Corporal Al Taber Valor with Life-Saving Award: Corporal Steve Gomez & Corporal Mindy Woods On January 10, 2012, Officer Jason Cox responded to a report of a subject planning to jump from the Key Bridge where he met up with the reporting party. He remained with them until the reporting party recieved a picture text from what appeared to be the middle of a bridge. Corporal Steve Gomez was the first to arrive at Key Bridge, where he observed a subject fitting the appropriate description. The subject began scaling the safety fence in an attempt to jump the bridge, so Corporal Gomez ran over and grabbed him around the waist. The subject's intent to go over was so intense he pulled the Corporal off the ground. Corporal Mindy Woods arrived to assist, while the subject continued to fight and resist. Corporal Woods was able to get a handcuff on one of his wrists as the struggle continued. Pulling both officers with him in his attempt to get over the fence, Corporal Woods was finally able to secure the loose end of the handcuff to the guardrail. At this time, Corporal Jim Mastoras and Corporal Al Taber arrived on scene. With significant effort, the four officers pulled the subject from the fence and properly secure him in handcuffs. Without their quick response and teamwork, this suicidal subject likely would have jumped to his death.

Valor with Life-Saving Award: Corporal Kevin Riley

While on patrol, Corporal Kevin Riley was driving on George Washington Memorial Parkway when he observed vehicles along the shoulder. As he approached, he discovered a SUV had gone off the roadway, traveled down the embankment and was in a wooded area only feet from the Potomac River. Immediately he began rescue efforts, pulling the three injured passengers from the burning SUV. Corporal Riley's exemplary performance at the scene saving these three lives reflects his high standards of commitment and dedication to duty and honor.

SMALL BUSINESS ROUNDTABLE

Take the Guesswork Out of Using Your Bank to Increase Your Business

Athena Ullrich, Rosemary Cruz and Greg Bernhard of The Business Bank briefed roundtable attendees on the ways a small business can work with their bank to increase business success.

A bank lending officer analyses the following to determine if the small business is an attractive applicant:

- You are the business small businesses by their very nature are an extension of the founder(s). The analysis of the business is, in reality, an analysis of you and your ability to repay the loan.
- Although the bank requires collateral to back up the loan, no bank wants to own it. Even within collateral there are levels of soundness i.e. a house valued at current market conditions provides stronger security than a yacht.

Banks evaluate the seven "Cs" of loan approval:

- 1. Credit Score is it acceptable?
- 2. Capacity can the business remain profitable given the added interest expense?
- 3. Capital money the principals have invested in the business
- 4. Collateral assets used to secure the loan
- 5. Character the reputation of the owner(s)
- 6. Conditions the economy the business is operating in
- 7. Commitment the owner(s) are required to personally guarantee the obligation

The bottom line from this roundtable?

Understanding what the lender is looking for and having the ability to satisfy those conditions will show the lender you are serious about the business and someone the lender will want to do business with.


A Brief History of Arlington's Best Business Awards (the ABBIEs)

In 1987, the Small Business Council of the Arlington Chamber of Commerce proposed to the Board of Directors a new event celebrating the best of Arlington's small businesses. The first award was presented in the spring of 1987, and so began Arlington's Small Business of the Year Awards. Today, the awards have expanded to include a number of categories, from green businesses to nonprofit organizations, as well as large businesses.

Ten years after the inception of the awards, the Arlington County government expressed a desire to make awards for members of our business community. Instead of having two separate awards programs, the County accepted the Chamber's invitation to collaborate on the existing program and rename it the ABBIE Awards and expand it to include medium and large businesses.

In 2008, the County came up with a new way to recognize Arlington Businesses - through the "People's Choice ABBIE Awards." Since then, every Fall, the Arlington County government holds the People's Choice ABBIES, which are awarded based on popular vote, and the Chamber continues to host the Arlington's Best Business (ABBIE) Awards every Spring. The Chamber's awards remain merit-based, as we hold true to the prestige and framework of our award program that has existed for 25 years.

The Chamber's selection committee consists of previous Best Business Award winners. All qualifying entries are scored based on how well the entrant meets the published criteria. Not all awards are presented each year when, in the opinion of the selection committee, a given award is not merited.


