#### **Governor Signs Arlington Tourism-Tax Extension**

On April 9, Governor Ralph Northam approved legislation to renew the transient occupancy tax (TOT), which is collected by Arlington County government and used to pay for tourism promotion, for three more years. Tourism is a key driver of Arlington's economy, and reinstating the TOT will help ensure that Arlington remains competitive in attracting travelers. Not only does it have a major impact in Arlington, but TOT generates an estimated \$1 million annually in promotional spending, which translates into \$5 million in tax revenue for the Commonwealth of Virginia.

Members can be involved in shaping policy positions through the Government Affairs & Economic Development Committee, which typically meets twice a month in the Chamber Boardroom.

The renewal of Arlington's TOT surcharge was the Chamber's chief priority for the 2018 General Assembly Session and had overwhelming support from the business community as a whole. In February, the Chamber sent letters to the Virginia House Finance Committee to renew the additional 0.25 percent tax for Arlington County.

#### Chamber Weighs in on FY 2019 Budget Items

The Chamber recently sent a letter to Arlington County Board Chair Katie Cristol, regarding the FY 2019 budget proposal. In the letter, the Chamber commended the County for keeping the tax rate flat while assessments rise in the budget plan, but raises concerns with several key parts of the proposal, including the continued tweaking of the Crystal City TIF in order to remove money to support the general fund. The Chamber also notes its opposition to the County's move to slash funding for planning on Lee Highway, noting its strong disapproval of any curtailing of the Lee Highway plan that would only consider "nodes," rather than the planning area as a whole. Additionally, the Chamber is opposed to increased parking meter fees and the current implementation of the recycling fee on businesses. Chamber President & CEO Kate Bates joined the County Board budget hearing on April 3, where she spoke on behalf of the Chamber.



#### **Business Organizations Unite Toward Metro Funding and Reform**

In March, the Arlington Chamber joined area chambers and other business groups in calling on lawmakers to provide \$154 million in annual capital funding for Metro's needs, along with achievable reform measures to ensure Virginia's quality of life and continued economic growth are preserved for years to come through a fully funded, well-governed, and efficiently operated Metro system.

In a letter to the lawmakers, the Chamber and other groups explain the critical role that Metro plays in the region's economic future, noting that Virginia's most recent corporate relocation, **Nestlé USA**, was made possible, largely, because of the ready access to Metro. Additionally, 100 percent of planned commercial development in Northern Virginia over the next five years is located within 0.5 miles of a Metro station.



#### CULPEPPER GARDEN

## Culpepper Garden I Groundbreaking Marks Beginning of Renovation

**Culpepper Garden**, Arlington's largest affordable senior living community with services, marked the beginning of a two-year, \$24.8M renovation of the original 204 apartments built in 1975 at a groundbreaking celebration on April 11. Known as **Culpepper Garden** I, the renovation is a partnership between Arlington Retirement Housing Corporation (ARHC) and Wesley Housing Development Corporation (WHDC), with funding from Arlington County, Virginia Housing Development Authority (VHDA), the Virginia Housing Trust Fund and tax credit equity through the Virginia Community Development Corporation (VCDC).

Noting that groundbreaking ceremony took place on the 50th anniversary of the Fair Housing Act, Marvin Turner, Director of the Department of Housing and Urban Development (HUD) DC Field Office, announced that HUD will be awarding 141 tenant protection vouchers, guaranteeing that most current and future residents will pay no more than 30 percent of their income in rent.



**Culpepper Garden** I will remain 100 percent affordable, with 208 units at 60 percent of the area median income (AMI) and two units at 80 percent of AMI. Upon completion of the project, **Culpepper** I will include 129 efficiency apartments, 74 one-bedrooms and seven two-bedrooms. While residents will need to be shuttled around among apartments somewhat as various portions of the project are completed, none will be displaced.




